

A penny doubled every day for 30 days is worth \$5,368,709.12.




FLOW CHART OF MEDIATION PROCESS

Joint assessment of the options


Mutual agreement between parties

What are the goals of mediation?

Even if disputants do not resolve the dispute, mediation frequently will "bring out" the real issues and enhance communications between the parties, fostering an improved working relationship.

The goals of mediation are for the disputing parties to:


- 1. share feelings and reduce hostilities,
- 2. clear up misunderstandings,
- 3. determine underlying interests and concerns,
- 4. find areas of agreement, and
- 5. incorporate those areas into solutions devised by the parties themselves.

The advantage of mediation over more traditional complaint procedures is that it provides an environment for creative problem-solving between the parties. Through the skilled assistance of the mediator, disputants are encouraged to listen, keep confidences, be empathetic, suspend preconceived judgements, respect each other's values, and focus on resolving the underlying conflict.



Opinion #2021-011, January 31, 2022

Appropriate to use the title "Florida Supreme Court Certified County Mediator"

Opinion #2021-010, January 31, 2022

Mediation is a <u>voluntary</u>, <u>consensual process</u>. Mediation <u>participants control the outcome</u> of mediation. The mediator's role includes identifying issues, reducing obstacles to communication, and maximizing alternatives to reach a voluntary agreement. The <u>mediator must maintain impartiality</u> and refrain from coercion and giving legal advice.

ETHICS

Opinion #2021-009, January 31, 2022

A mediator who is advised that the case has been settled and files a conference report stating, "settled prior to the mediation," is not required to further follow up with the parties.

Opinion Number: 2021-008

Date Issued: November 26, 2021

A mediator may report "no agreement," "agreement," or "partial agreement" to the court without comment or recommendation. No other descriptors or modifiers may be used in the mediator report unless the parties have consented to them in writing.

ETHICS

Opinion #2021-007, November 26, 2021

A <u>conflict check</u> must be performed by a mediator for all "mediation participants" to allow <u>self-determination of the parties</u>.

Opinion #2021-006, November 26, 2021

The mediator should disclose the <u>potential conflict</u> to all parties as soon as <u>practical</u>* after the mediator is aware of it. The mediator may continue to serve <u>only if all parties agree</u>.





- Common issues in family mediation:
 - Timesharing with children
 - Tax benefits related to children
 - Tax consequences of selling or dividing property
 - Fairly dividing property


